It is submitted that as per order dated 23/06/2021 of the Hon'ble High Court of Kerala, a meeting of State Multilevel Marketing/Direct Selling Monitoring Authority was convened on 06/11/2021. It was decided in the meeting that reports from various departments with regard to the functioning of M/s Indus Viva Health Sciences Pvt. Ltd. is to be obtained. The Subject Expert in the Monitoring Authority, State Goods & Services Tax Department and Police Department submitted their reports.

It is submitted that after Scrutiny of the records submitted by the company and reports received from the concerned departments, it is found that M/s Indus Viva Health Sciences Pvt. Ltd.
